WHEREAS, The City received seven proposals to provide consulting services, which were reviewed, evaluated, and three company's qualified for final interview; and,

WHEREAS, upon completion of the interviews by an evaluation team composed of the City Police Department, City Fire Department, City Radio Services Department and the Polk County Sheriff's Office and based on the evaluation criteria in the RFP, that RCC Consultants Incorporated, 2425 Millcreek Ct. Tallahassee, Florida 32308, President Mike Hunter was determined to be the most qualified consultant; and,


WHEREAS, the evaluation team desires the City Council award RCC Consultants Incorporated, 2425 Millcreek Ct. Tallahassee, Florida 32308, President Mike Hunter the interoperability project and authorized the Chief of Police or her representatives to negotiate a contract for services with said company; and,

WHEREAS, the negotiated contract be returned to the City Council for approval and authorization for the City Manager to sign said agreement as the authorized representative of the City of Des Moines, Iowa; and,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the award of Request for Proposal V08-047 be granted to RCC Consultants Incorporated, 2425 Millcreek Ct. Tallahassee, Florida 32308, President Mike Hunter and the City Manager and the Chief of Police of the City of Des Moines, Iowa is hereby authorized and directed to negotiate an appropriate contract with RCC Consultants, which will be returned to the City Council for approval.




