SET HEARING FOR VACATION AND CONVEYANCE OF 18TH STREET BETWEEN CARPENTER AVENUE AND KEOSAUQUA WAY TO ADJOINING PROPERTY OWNERS FOR \$2,064

WHEREAS, on March 24, 2008, by Roll Call No. 08-485, the City Council adopted a recommendation from the City Plan and Zoning Commission that 18th Street between Carpenter Avenue and Keosauqua Way, hereinafter more fully described, be vacated and sold; and

WHEREAS, the grantees identified below are the owners of property abutting such right-of-way and have offered to the City of Des Moines the purchase price identified below for the vacation and purchase of the portion of such right-of-way described below.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating 18th Street between Carpenter Avenue and Keosauqua Way more specifically described as follows:

All that part of 18th Street right-of-way lying West of and adjoining Lot 12, Garden Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as described below to the grantees and for the consideration identified below:

To: Kenoyer and Associates, L.L.C. for \$ 864.00

All that part of vacated East 1/2 of 18th Street right-of-way lying West of and adjoining the North 99.0 feet of Lot 12, Garden Addition, an Official Plat, and all of Vacated 18th Street right-of-way lying West of and adjoining the South 63.0 feet of said Lot 12, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Subject to driveway Access for property at 1720 Carpenter Avenue, and subject to any utilities now in place.

To: Aterra 3, 1901 Carpenter, DSM, L.L.C. for \$1,200.00
