## HOLD HEARING FOR APPROVAL OF PROPOSED LEASE OF CITY-OWNED PROPERTY IN THE VICINITY OF 600 HOLCOMB AVENUE TO CONSOLIDATED SUPPLY COMPANY OF DES MOINES FOR \$250.00

**WHEREAS**, the City of Des Moines owns real property in the vicinity of 6<sup>th</sup> Avenue and Holcomb Avenue ("Property"), more particularly described below:

Lot 163, Block 6, in HOME PARK ADDITION, an Official Plat, now included in and forming a part of the City of Des Moines, Iowa,

which Property has been leased by the City to Consolidated Supply Company of Des Moines ("Consolidated Supply") since 1996; and

WHEREAS, on January 27, 2003, by Roll Call Number 03-218, City Council approved a five (5) year lease agreement with Consolidated Supply, commencing retroactively on March 19, 2001 and ending on March 18, 2006, with lease terms requiring that Consolidated Supply provides additional consideration in the form of maintenance of the Property and of adjacent City-owned property; and

WHEREAS, Consolidated Supply has continued to maintain the Property and the adjacent Cityowned property since the expiration of the previous lease agreement on March 18, 2006; and

WHEREAS, Consolidated Supply wishes to enter into a Lease Agreement for another five (5) year term, retroactive to April 1, 2006 and ending on March 31, 2011; and

WHEREAS, the City of Des Moines has no immediate or short term municipal purpose or use for the Property, and it is in the best interest of the City to enter into the Lease Agreement with Consolidated Supply, which Lease Agreement can be terminated by either party with 60 days notice; and

WHEREAS, on April 7, 2008, by Roll Call No. 08-568, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on April 21, 2008, at 5:00 p.m., in the Council Chambers; and

WHEREAS, due notice of said proposal to lease the Property for a term of five (5) years was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed lease, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
