PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2008 STORM SEWER REPAIR CONTRACT 1; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS THE UNDERGROUND COMPANY, LTD., DUANE BURKHARDT, PRESIDENT, \$402,504.00

WHEREAS, on March 24, 2008, under Roll Call No. 08-461, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2008 Storm Sewer Repair Contract 1, 08-2008-001

The improvement includes construction of new storm sewers to modify the existing storm sewer system at two locations: 1) the intersection of Grand Avenue & 45th Street and 2) 16th Street from Euclid Avenue to Douglas Avenue, Des Moines, Iowa. These projects will allow for the abandonment of deteriorated, undersized storm sewers that are located on private property. This contract includes construction of the storm sewers, manholes, intakes, restoration of pavement, landscaping, and other incidental items; in accordance with the contract documents including Plan File Nos. 489-001/024

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement.
