## RESOLUTION AUTHORIZING AND APPROVING PARTIAL RELEASE OF UTILITY EASEMENT RESERVATION FOR A PORTION OF INGERSOLL AVENUE RIGHT-OF-WAY BETWEEN 17<sup>TH</sup> STREET AND 18<sup>TH</sup> STREET

WHEREAS, on July 18, 2005, by Roll Call No. 05-1662, the City Council adopted a recommendation from the City Plan and Zoning Commission that a portion of the Ingersoll Avenue right-of-way between 17<sup>th</sup> Street and 18<sup>th</sup> Street, hereinafter more fully described, be vacated and sold; and

WHEREAS, on March 28, 2005, by Roll Call No. 05-707, the City Council adopted a recommendation from the City Plan and Zoning Commission that the East/West alley between Ingersoll Avenue and Grand Avenue from 17<sup>th</sup> Street to 18<sup>th</sup> Street, hereinafter more fully described, be vacated and sold; and

WHEREAS, on November 21, 2005, by Roll Call No. 05-2790, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on December 5, 2005, at 5:00 p.m., in the Council Chamber; and

WHEREAS, on December 5, 2005, by Roll Call No. 05-2922, the City Council of the City of Des Moines, Iowa approved the sale and conveyance of such right-of-way to Striggles Legacy II, LLC for \$2,000.00; and

WHEREAS, Striggles Legacy II, LLC has submitted a site plan to the City's Community Development Department, which plan has been approved, and will submit building plans for construction of residential units, retail commercial space and parking improvements in and adjacent to the previously transferred right-of-way, and in the process has requested that a portion of the easement reservation for utilities upon said property, as described in the Quit Claim Deed from the City to Striggles Legacy II, LLC and recorded in the office of the Recorder of Polk County, Iowa on January 12, 2006, in Book 11482, Pages 823-829, be released by the City of Des Moines; and

WHEREAS, the City has no need for the existing easement reservation upon the portion of the property to be released.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:
