HOLD HEARING FOR CORRECTED VACATION AND CONVEYANCE OF VARIOUS SEGMENTS OF RIGHT-OF-WAY IN THE VICINITY OF 3001 LOGAN AVENUE TO THE STATE OF IOWA

WHEREAS, on April 21, 2008, by Roll Call No. 08-720, after notice and public hearing, the City Council intended to approve the vacation and conveyance of various segments of right-of-way in the vicinity of 3001 Logan Avenue to the State of Iowa, described below, but said Roll Call contained an error in the legal description of Parcel A therein; and

WHEREAS, the State of Iowa is the owner of property abutting such right-of-way and has paid to the City of Des Moines the purchase price of \$13,280.00 for the purchase of such right-of-way described below; and

WHEREAS, on June 23, 2008, by Roll Call No. 08-1099, it was duly resolved by the City Council that the proposed vacation and conveyance of such rights-of-way be set down for hearing on July 14, 2008, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate and convey public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance of public rights-of-way, as described below, are hereby overruled and the hearing is closed.
2. There is no public need for the rights-of-way proposed to be vacated and the public would not be inconvenienced by reason of the vacation of various segments of right-of-way in the vicinity of 3001 Logan Avenue, more specifically described as follows:

Upon final passage of an ordinance vacating the said rights-of-way, the City Clerk is authorized and directed to forward the original of the said Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Real Estate Division of the Engineering Department for the purpose of causing said documents to be recorded.
