HOLD HEARING FOR CONVEYANCE OF AN OVERHEAD ELECTRIC LINE EASEMENT ACROSS CITY-OWNED PROPERTY AT 1615 SE 14TH STREET TO MIDAMERICAN ENERGY COMPANY FOR \$1

WHEREAS, MidAmerican Energy Company has requested an Overhead Electric Line Easement across City-owned property at 1615 SE 14th Street for installation of a new wood pole to raise service that is too low, as determined during an Iowa Utilities Board inspection; and

WHEREAS, on July 14, 2008, by Roll Call No. 08-1192, it was duly resolved by the City Council that the proposed conveyance of an overhead electric line easement across City-owned property at 1615 SE 14th Street, be set down for hearing on July 28, 2008, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to convey this public real property was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- Upon due consideration of the facts and statements of interested persons, the objections to the proposed conveyance of this easement, as described below, are hereby overruled and the hearing is closed.
- 2. There is no public need for the property described below and the public would not be inconvenienced by reason of the conveyance of this easement across City-owned property at 1615 SE 14th Street, more specifically described as follows:

An overhead electric line easement consisting of a strip of land 5.0 feet wide by approximately 30.0 feet long, situated in the following property: Lot 11 in Block 9, South Riverside Park, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

3. That the sale and conveyance of such overhead electric line easement to MidAmerican Energy Company for \$1 be and is hereby approved.

4. The Mayor is authorized and directed to sign the Overhead Electric Line Easement for the conveyance as identified above, and the City Clerk is authorized and directed to attest to the Mayor's signature.

- 7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Easement and copies of the other documents to the grantee.
- 8. There will be no proceeds associated with the conveyance of this easement.
