PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON
2008 EXPANDED STREET RESURFACING PROGRAM - CONTRACT 2;
RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS GRIMES ASPHALT & PAVING CORP., J M YONKER, PRESIDENT, \$1,500,141.60

WHEREAS, on June 23, 2008, under Roll Call No. 08-1094, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2008 Expanded Street Resurfacing Program - Contract 2, 06-2008-018

The improvement includes scarification of existing asphalt streets, furnish and place hot mix asphalt, and furnish and place pavement markings, and other incidental items; in accordance with the contract documents, including Plans File Nos. 490-150/170, at the following locations within the City of Des Moines, Iowa:

- 30th Street from Forest Avenue to Hickman Road
- Urbandale Avenue from 34th Street to Beaver Avenue
- 6th Avenue0 from Birdland Drive to Euclid Avenue
- Guthrie Avenue from Delaware Avenue to E 23rd Street
- Guthrie Avenue from Dixon Street to Delaware Avenue
- Maury Street from SE 14th Street to E 22nd Street
- Maury Street from SE 6th Street to SE 14th Street

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement.
