2008 EXPANDED STREET RESURFACING PROGRAM - CONTRACT 3
AND FIXING A DATE FOR RECEIVING OF BIDS ON AUGUST 26, 2008
AND PUBLIC HEARING ON SEPTEMBER 8, 2008
ENGINEER'S ESTIMATE IS \$632,400.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Jurisdictional Engineer, submitting plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of cost for the construction of the following improvement:

2008 Expanded Street Resurfacing Program - Contract 3, 06-2008-019

The improvement includes scarification of existing asphalt streets, furnish and place hot mix asphalt, and other incidental items; in accordance with the contract documents, including Plans File Nos. 491-104/109, at the following locations:

- 56th Street - College Avenue to Franklin Avenue
- 50th Street - Hickman Road to Urbandale Avenue
- 56th Street - Madison Avenue to Aurora Avenue
- Sheridan Avenue - 44th Street to Beaver Avenue
- Washington Avenue - 16th Street to ML King Jr. Pkwy.
- Clinton Avenue - 6th Street to 12th Street
- Royer Street - E 14th Street to Dead End East of E 14th Street
- Pleasantview Drive - SE 14th Street to SE 17th Street
- SE 8th Street - Park Avenue to Indianola Road

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$632,400.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Jurisdictional Engineer; and that payment for the cost of said improvement shall be paid from from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on September 8, 2008, at which time this Council will consider any objections offered thereto or to the making of said improvement.
