APPROVAL OF UNITED WAY OF CENTRAL IOWA COMMUNITY IMPACT
INVESTMENT AGREEMENT FOR COMMUNITY ACTION PROGRAM

WHEREAS, the City of Des Moines Department of Community Development utilizes funds from United Way of Central Iowa to pay staff salaries for the Des Moines Community Action Program conducted through its Community Services Division; and

WHEREAS, the United Way of Central Iowa has forwarded a United Way of Central Iowa Investment Agreement FY2008-2009 on file with the City Clerk as Exhibit "A" which allocated \$21,994.04 to the City of Des Moines for use in support of the Des Moines Community Action Program during the period of time from July 1, 2008 through June 30, 2009 also known as FY2008-2009; and

WHEREAS, such grant agreement provides that all funds be used in compliance with the US Patriot Act and other counterterrorism laws, that the City indemnify and hold harmless UWCI for the negligent acts of the City, its agents and subcontractors, and that the City affirm the United Way Diversity Policy; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the United Way of Central Iowa Community Impact Investment Agreement FY2008-2009 which allocates \$21,994.04 to the City of Des Moines for use in support of the Des Moines Community Action Program during the period of time from July 1, 2008 through June 30, 2009, is hereby approved; and

BE IT FURTHER RESOLVED that the Mayor and Community Development Director are hereby authorized and directed to execute the above-referenced agreement on behalf of the City and the City Clerk to attest to their signatures.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized and directed to execute any changes in the terms, conditions, or amounts specified in this agreement above-referenced Investment Agreement and the Community Development Director or his designee is designated to sign all fiscal and program forms required by this agreement.
