CONSENT TO LEASEHOLD MORTGAGE TO THE LIBERTY BANK, F.S.B.

WHEREAS, on March 24, 2008, by Roll Call No. 08-515, the City Council approved a lease of the Greenwood Building at 100 45th Street (the former Science Center of Iowa Building) to The Academy, to operate a non-profit school with classes to begin in Fall 2008, and to construct significant improvements to such building, for a total of \$52,473.20 rent in the first year for an initial term of 20 years with two renewal periods of 10 years, upon mutual agreement of the parties, for the area as described below:
