WHEREAS, the Fleet Maintenance Center requested the Finance Department Procurement Division to solicit bids for purchase of seven (7) side-loading refuse trucks, two (2) of which are replacement units, and five (5) of which are new units for the Single-stream Automated Recycling Collection Program, and sale of twelve (12) existing refuse trucks, for use by the Solid Waste Division of the Public Works Department; and

WHEREAS, bids for five (5) of the seven (7) refuse trucks were requested based on best cost and delivery time in order to minimize refuse truck rental expenses necessary for start-up of the Single-stream Automated Recycling Collection Program; and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V09-010 to eleven (11) potential bidders with four (4) bids received; and

WHEREAS, the low dollar compliant bid for two (2) of the five (5) refuse trucks needed for early delivery was received from Truck Country of Des Moines, 4300 NE 14th Street, Des Moines, IA 50313, at a total cost of \$392,000.00; and

WHEREAS, the low dollar compliant bid for the other three (3) early delivery refuse trucks was received from Peterbilt of Des Moines, 3445 Adventureland Drive, Altoona IA 50009, at a total cost of \$637,569.00; and

WHEREAS, the low dollar compliant bid for the two (2) replacement refuse trucks was received from Peterbilt of Des Moines, 3445 Adventureland Drive, Altoona, IA 50009, at a total cost of \$419,518.00; and

WHEREAS, the high dollar bid for sale of eleven (11) of the existing refuse trucks was received from Elliott Equipment Company, 5225 Beisser Drive, Grimes, IA 50111, at a total sale price of \$284,500.00; and

WHEREAS, funding in the amount of \$1,029,569.00 is available through lease purchase financing, and \$419,518.00 is available from PWK100101/Solid Waste Collection; and

WHEREAS, the Procurement Administrator and the Fleet Maintenance Manager recommend approval of the low dollar compliant bids;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the aforementioned low dollar compliant bids for purchase of seven (7) side-loading refuse trucks at a total cost of \$1,449,087.00, \$1,029,569.00 of which is subject to the necessary financing through the City's master lease-purchase agreement with De Lage Lande, Supplement C-2.
