RESOLUTION APPROVING THE CONCURRENT NOTICE TO THE PUBLIC OF FINDING OF NO SIGNIFICANT IMPACT ON THE ENVIRONMENT AND INTENT TO REQUEST RELEASE OF FUNDS FROM THE IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT FOR FUNDS FROM THE STATE CDBG SUPPLEMENTAL HOUSING DISASTER RECOVERY FUND

WHEREAS, the Iowa Department of Economic Development (IDED) has received U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) funds under the Supplemental Appropriations Act of 2008 (P.L. 110-252); and

WHEREAS, on October 13, 2008, by Roll Call No. 08-1809, the City Council approved a CDBG Housing Disaster Recovery Fund Contract (08-DRH-009) (Contract) with IDED in the amount of \$588,507, with the primary purpose of providing funding for housing repair and rehabilitation, homebuyer assistance and interim mortgage assistance to low and moderate income persons and families in the City of Des Moines who meet defined eligibility criteria, as well as for certain administrative costs; and

WHEREAS, the City is required by HUD to prepare an Environmental Review Record (ERR) before federal or nonfederal funds can be released for the use of program activities; and

WHEREAS, the Department of Community Development is the HUD designated Responsible Entity (RE) and is required to prepare and maintain the ERR for HUD Grants awarded to projects in the City of Des Moines, Iowa, and has determined that the CDBG Housing Disaster Recovery project is Categorically Excluded subject to Sec.58.5 of the federal environmental review procedures under 24CFR Part 58.35, and which applicable ERR is on file in the office of the City Clerk; and

WHEREAS, the City is further required by HUD to publish notice of the results of the ERR and notice of the City's intent to request the release of funds under the Contract, which notice is attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the City Clerk is authorized and directed to publish the attached "Concurrent Public Notice of Finding of No Significant Impact on the Environment and Public Notice of Intent to Request Release of Funds" (Exhibit A) in the <u>Des Moines Register</u> on October 28, 2008, in accordance with 24 CFR 58.42, 58.43, and 58.44.
