APPROVAL OF VISION IOWA GRANT AWARD AGREEMENT BEWTEEN THE CITY, THE EDMUNDSON ART FOUNDATION, INC. AND THE VISION IOWA BOARD FOR \$1,000,000.00 FOR DEVELOPMENT OF A SCULPTURE GARDEN IN "WESTERN GATEWAY" PARK

BE IT FURTHER RESOLVED that the City Manager or his designee is hereby directed to administer all terms of the Vision Iowa Grant agreement including the satisfaction of all conditions and provision of all documentation required for the disbursement of Vision Iowa Grant funds and the maintenance and provision of all accounting records, documentation and reports.
