APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS FOR GOOD CAUSE AND APPROVING PROCUREMENT OF BULK FUEL AT A TOTAL ANNUAL ESTIMATED COST OF \$3,000,000.00

WHEREAS, Roll Call # 07-772, dated April 23, 2007, approved an annual contract award to Keck Inc., 320 SW 9th Street, Des Moines, IA 50309, to procure fuel products for use by the Equipment Maintenance Center, as well as other City departments; and

WHEREAS, the award was based on a "bid margin" that would include overhead, profit, and delivery charges that would be added to or deleted from the daily average price per gallon of diesel ethanol, E85 or gasohol as reported to the Iowa Department of Transportation by Axxis Petroleum; and

WHEREAS, such contract with Keck Inc. expired on April 23, 2008; and

WHEREAS, market conditions for fuel products are volatile throughout the year, and historical data is available to show trends for high and low prices, and analysis of the market can result in cost savings to the City by buying bulk fuel needs for the entire City for the entire year when conditions are favorable for the greatest possible savings; and

WHEREAS, the Fleet Oversight Committee recommends authority be granted to the City Manager to take advantage of the most favorable market conditions, which requires immediate action and flexibility in determining a provider, to secure the best price available on any given day; and

WHEREAS, the City Manager recommends that the procurement of bulk fuel be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding is available from CMO011400/Fuel Services.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that good cause has been shown to exempt the procurement of bulk fuel from the Procurement Ordinance competitive bidding requirements in an amount not to exceed \$3,000,000.00.
