WHEREAS, on June 7, 2004, by Roll Call No. 04-1167, in response to the above referenced COC application, the City Council approved a 2003 Supportive Housing Program (SHP) Grant Agreement by and between HUD and the City of Des Moines, in the amount of \$171,284 for the Iowa Homeless Management Information Network; and

WHEREAS, HUD has now forwarded Continuum of Care Grantee Closeout Certifications for the Buchanan Transitional Living Center Project and the Iowa Homeless Management Information Network, on file with the City Clerk as Exhibits A and B respectively, and by this reference made a part hereof.
