WHEREAS, FEMA requires a Letter of Agreement, be provided before March 24, 2009, stipulating that all necessary information to show that the levees comply with 44 C.F.R. 65.10, will be provided to FEMA before March 24, 2011.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Public Works Director and Mayor are hereby authorized and directed to sign the Letter of Agreement and Request for Provisionally Accredited Levee (PAL) Designation and Agreement to Provide Adequate Compliance with the Code of Federal Regulations, Title 44, Section 65.10 between the Federal Emergency Management Agency and the City of Des Moines, Iowa, a copy of which is on file in the office of the City Clerk.
