RESOLUTION AUTHORIZING THE REDEMPTION OF OUTSTANDING PUBLIC PARKING SYSTEM REVENUE BONDS, TAXABLE SERIES 2000B, DATED JUNE 12, 2000 OF THE CITY OF DES MOINES, IOWA, AND DIRECTING NOTICE OF REDEMPTION TO BE GIVEN

WHEREAS, the City Council has heretofore, by Roll Call No. 00-1578 approved on May 24, 2000, authorized the issuance of \$9,625,000 Public Parking System Revenue Bonds, Taxable Series 2000B, dated June 1, 2000 (the "Taxable Series 2000B Bonds"); and

WHEREAS, the Taxable Series 2000B Bonds maturing after June 1, 2008 may be called for redemption and paid before maturity on said date or any date thereafter, from any funds regardless of source, in whole or from time to time in part, upon giving notice in the manner provided in the foregoing resolution authorizing the issuance of the Taxable Series 2000B Bonds; and

WHEREAS, it is deemed necessary and advisable that the Taxable Series 2000B Bonds be so redeemed and notice of redemption be given.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

Section 1. That the outstanding Public Parking System Revenue Bonds, Taxable Series 2000B, dated June 1, 2000, maturing after June 1, 2009 in the principal amount of \$3,490,000, be and the same are hereby redeemed as of June 1, 2009.

Section 2. The Finance Director/Treasurer is hereby authorized and directed to cause to be deposited in a separate fund (i) \$678,000 being released from the Debt Service Reserve Fund established in respect of the Taxable Series 2000B Bonds and other bonds issued on a parity therewith, and (ii) the proceeds of the Public Parking System Revenue Refunding Capital Loan Notes, Taxable Series 2009D, dated the date of delivery, and apply such amount to pay all principal of the redeemed Taxable Series 2000B Bonds on the date of redemption. Principal of and interest on the Taxable Series 2000B Bonds which is due to be paid on June 1, 2009 shall be paid from funds previously collected for that purpose and shall be deposited in the Public Parking System Revenue Bond Sinking Fund on the date of issuance of the Taxable Series 2009D Notes.




