PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON BLANK PARK ZOO 2009 WALKWAY & STORM SEWER REPLACEMENT; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS SHEETS EXCAVATING, LTD., CHARLES SHEETS, PRESIDENT, \$116,162.50

WHEREAS, on February 9, 2009, under Roll Call No. 09-163, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Blank Park Zoo 2009 Walkway & Storm Sewer Replacement, 11-2009-001

The improvement includes reconstructing approximately 1,150 square yards of 6-inch HMA walkway with excavation of subgrade, subdrain, areas of HMA overlay, storm sewer removal and replacement, and other incidental items; all in accordance with the contract documents including Plans File Nos. 495-022/026 at the Blank Park Zoo, 7401 SW 9th Street, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement.


BE IT FURTHER RESOLVED: That the bid security of the unsuccessful bidders be and is hereby authorized and directed to be returned.






