ACCEPTING PROPOSAL OF ALTA PLANNING + DESIGN, INC. FOR THE PROVISION OF PROFESSIONAL CONSULTING SERVICES FOR THE DEVELOPMENT OF A BICYCLE AND TRAILS MASTER PLAN AND APPROVING AGREEMENT FOR THE PROVISION OF THE SAME

WHEREAS, the City desires to plan for the future of its bicycle street lanes and trail network; and

WHEREAS, on September 18, 2008, the Procurement Division solicited proposals for planning services for the Bicycle and Trails Master Plan by issuing Request for Proposal (V09-33) Bicycle and Trails Master Planning Services, which was mailed to eight potential bidders with two proposals received; and

WHEREAS, the Evaluation and Selection Committee has reviewed the proposals and has recommended that a contract for the provision of such consulting services be awarded to Alta Planning + Design, Inc., 711 SE Grand Avenue, Portland, Oregon 97214 for the sum of \$99,950; and

WHEREAS, the an Agreement for Professional Services with Alta Planning + Design, Inc. has been negotiated by City staff and signed by Alta Planning + Design, Inc. , a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOVED by the City Council of the City of Des Moines, Iowa, that the proposal submitted by Alta Planning + Design, Inc. is hereby accepted.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to execute the Agreement for Professional Services with Alta Planning + Design, Inc., a copy of which is on file in the City Clerk's Office, for the provision of the above described services in an amount not to exceed \$99,950.00, on behalf of the City and the City Clerk is directed to attest to his signature.
