WHEREAS, Goudelock entered into an agreement to sell his home, but the sale fell through in October, 2008, and his real estate agent was not been able to find another willing buyer; and

WHEREAS, on December 8, 2008, by Roll Call No. 08-2132 the City Council extended the date for Goudelock to comply with the residency requirement to April 30, 2009; and

WHEREAS, Goudelock has made an offer to purchase a home in Des Moines contingent upon the sale of his home in West Des Moines; and

WHEREAS, Goudelock is making a good faith effort to comply with the terms of the City's residency requirement, but due to no fault of his own he has not been able to comply, and will not be able to comply by April 30, 2009; and

WHEREAS, in the past the City Council has extended time for compliance with the residency requirement where the need to do so was created by extenuating circumstances.
