RESOLUTION APPROVING VOLUNTARY ANNEXATION OF TERRITORY IN UNINCOROPORATED POLK COUNTY AT 4880 NE 23RD AVENUE (H. Dwayne Crozier)

WHEREAS, the City of Des Moines has received the accompanying Application for Voluntary Annexation from H. Dwayne Crozier, seeking the voluntary annexation by the City of Des Moines of approximately 2.597 acres of land he owns in unincorporated Polk County in the vicinity of 4880 NE 23rd Avenue, generally shown on Exhibits A and A-2 and more specifically described below; and

WHEREAS, on February 9, 2009 by Roll Call No. 09-186, the City Council resolved that the proposed annexation be set down for consideration by the City Council at a public hearing to be held in the Council Chambers on April 6, 2009, at 5:00 p.m.; and

WHEREAS, notice of the proposed annexation was given to the Polk County Board of Supervisors and to the Delaware Township Board of Trustees by letter of February 5, 2009 and they were invited to a consultation meeting by City staff held at 1:10 p.m. on February 19, 2009 in the Kofu Conference Room at City Hall to discuss the proposed annexation; and

WHEREAS, neither the county nor township sent representatives to the consultation meeting; and

WHEREAS, due notice of the public hearing was published in the Des Moines Register on March 13, 2009 as provide by law, setting forth the time and place for hearing on the proposed annexation; and

WHEREAS, in accordance with the published and mailed notice, those interested in the annexation, both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council; and

WHEREAS, the Territory proposed to be annexed is not within the boundaries of any city and is located within two miles of the boundaries of the cities of Pleasant Hill and Altoona;

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts, statements of interested persons and arguments of counsel, the objections to the proposed annexation are hereby overruled and the hearing is closed.
- 2. The annexation of the Territory generally shown on the maps attached hereto as Exhibits A and A-2 more specifically described below, is hereby found to be consistent with the City's long range plans for the area, and is hereby approved.

Parcel "C" as shown by the Plat of Survey recorded in the office of the Recorder of Polk County, Iowa, on March 3, 2009, in Book 12936, at Page 258, and more specifically described as follows:
