Corell, President, 1300 Lincoln Street, West Des Moines, IA, 50265 dated April 6, 2009, for the construction of the following improvement:

High Street Realignment - 10th Street to 14th Street - Phase 2, 06-2008-008
RM-1945(736)--9D-77

The improvement includes pavement removal and replacement, sidewalk removal and replacement, excavation, storm sewer, water main relocation, traffic signals, pavement markings, construction survey, sodding and site restoration, all accordance with the contract documents including Plan File Nos. 496-88/128, on High Street from 12th Street to 14th Street, Des Moines, Iowa

the same to be performed in accordance with the plans and specifications which have been heretofore approved by this Council, be and the same are hereby approved. BE IT FURTHER RESOLVED: That after said contract has been executed by the Mayor, the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.

BE IT FURTHER RESOLVED: That the attached communication from said Contractor requesting permission to sublet designated items and the attached Permission to Sublet form, be and are hereby approved subject to each subcontractor's compliance with the City of Des Moines Contract Compliance Program. The City Manager is hereby directed to sign said Permission to Sublet form granting permission for said listed subcontractor to work on said improvement upon each subcontractor's compliance with the City of Des Moines Contract Compliance Program as monitored by the Engineering Department.
