WHEREAS, the City of Des Moines Police Department, is filing a grant application through the Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, 2009 Recovery Act: Edward Byrne Memorial Justice Assistance Grant (JAG) Formula Program: Local Solicitation, to request funding directed to the JAG Purpose Area-Law Enforcement Programs. The Des Moines Police Department intends to direct the funding to improve forensic capabilities, upgrade technology, purchase equipment to address officer safety and provide for procedural efficiencies; and,

WHEREAS, the Department of Justice, Office of Justice Programs, Bureau of Justice Assistance has deemed that our grant award is contingent on a Memorandum of Understanding (MOU) signed by the Authorized Representative from the County of Polk and Cities of Altoona, Ankeny, Clive, Johnston, Pleasant Hill, Urbandale and West Des Moines designating the City of Des Moines as the official applicant and fiscal agent; and,

WHEREAS, the total award amount is \$1,502,161 with allocations as determined by the Bureau of Justice Statistics to the County of Polk (\$90,299) and Cities of Altoona (\$18,060), Ankeny (\$31,459), Clive (\$32,041), Johnston (\$10,195), Pleasant Hill (\$11,069), Urbandale (\$49,810) and West Des Moines (\$80,395) and,

WHEREAS, the award amount for the City of Des Moines is \$1,178,833; and,

WHEREAS, there is no match requirement; and,

WHEREAS, the grant period is from October 1, 2008 to September 30, 2012;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the grant application under the 2009 Recovery Act: Edward Byrne Memorial Justice Assistance Grant (JAG) Formula Program is hereby approved, with the Mayor authorized to sign the application and the Memorandum of Understanding on behalf of the City, with the City Clerk to attest to the Mayor's signature, and the City Manager and his staff directed to take any and all steps necessary to timely file the grant application and execute said MOU.




