AUTHORIZING AND APPROVING CONTRACT AMENDMENT #3 TO THE COMMUNITY DEVELOPMENT BLOCK GRANT HOUSING DISASTER RECOVERY FUND CONTRACT WITH IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT (CONTRACT NUMBER 08-DHR-009)

WHEREAS, there is a continued need in the City of Des Moines for home repairs due to the heavy rains and flooding in 2008; and

WHEREAS, the Iowa Department of Economic Development (IDED) is administering the Community Development Block Grant (CDBG) Disaster Recovery Funds per a statewide allocation plan approved by the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, the City of Des Moines was awarded \$1,177,014 in Federal CDBG funds administered by IDED, of which half of those funds were provided to the City by the approval of the CDBG Housing Disaster Recovery Fund Contract with Iowa Department of Economic Development on October 13, 2008 (Roll Call 08-1810), and of which the remaining funds are to be provided through Contract Amendment Number 3 to said Contract (attached hereto as Exhibit A) which must first be approved by City Council.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Contract Amendment Number 3 to the Community Development Block Grant Housing Disaster Recovery Fund Contract with Iowa Department of Economic Development (Contract Number 08-DHR-009), as attached hereto, is approved; the Mayor Pro Tem is authorized and directed to sign said Amendment; and the Chief Deputy City Clerk is authorized and directed to attest to his signature.
