RESOLUTION APPROVING ASSIGNMENT OF TAX SALE CERTIFICATES TO GREATER DES MOINES HABITAT FOR HUMANITY INC., FOR THE DEVELOPMENT OF LOW TO MODERATE INCOME OWNER-OCCUPIED HOUSING

WHEREAS, Iowa Code § 446.19A permits cities to acquire tax sale certificates for vacant lots and for abandoned property assessed as residential property or as commercial multifamily property at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the holder in the amount then due to redeem the certificate, and to give notice of expiration of the redemption period upon an expedited schedule, all for the purpose of encouraging the acquisitions and rehabilitation of abandoned dwellings and the development of vacant lots for residential use; and

WHEREAS, the parcels described below are scheduled to be sold at tax sale for nonpayment of taxes; and

WHEREAS, the parcels described below are vacant lots assessed as residential property, and all such parcels are suitable for use for low or moderate income housing following redevelopment; and,

WHEREAS, Greater Des Moines Habitat for Humanity, Inc., ("Habitat for Humanity") represented by Lance Henning, Executive Director, have offered to redevelop the parcels described below for use for low or moderate income owner-occupied housing if the City will acquire and assign the tax sale certificates for the parcels to them; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The Agreement now on file in the Office of the City Clerk between the City and Greater Des Moines Habitat for Humanity, Inc. (as the "Applicant"), whereby the City agrees to assign to Applicant the tax sale certificate(s) for the parcels described in the accompanying Council Communication in consideration of the reimbursement of the City's acquisition costs and an undertaking by the Applicant to rehabilitate the parcels for low and moderate income owneroccupied housing, is hereby approved.
- 2. The Mayor is hereby authorized and directed to sign the Agreement on behalf of the City of Des Moines.
- 3. Upon execution of the Agreement by all parties and receipt of payment from Applicant pursuant to the Agreement to fully reimburse the City for the City's cost to acquire any
