WHEREAS, the U.S. Department of Homeland Security, Office of Grants and Training, and Iowa Homeland Security and Emergency Management Division identified key assets and critical infrastructure sites of national significance, in accordance with the federal Buffer Zone Protection Program criteria; and,

WHEREAS, the Police Department participated in the preparation of two Buffer Zone Protection Plans and Vulnerability Reduction Purchasing Plans for sites identified in the Des Moines area; and,

WHEREAS, the U.S. Department of Homeland Security, Office of Grants and Training, and Iowa Homeland Security and Emergency Management Division have approved funding in the amount of \$286,380 (no local match requirement) to enhance security and response capabilities of the Des Moines Police Department to defend the identified sites against a potential attack; and,

WHEREAS, the equipment required to accomplish the protect and defend missions has been identified in the Vulnerability Reduction Purchasing Plans and the equipment was approved for purchase by the U.S. Department of Homeland Security, Office of Grants and Training, and Iowa Homeland Security and Emergency Management Division;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts the 2008 Buffer Zone Protection Program Agreements; 2008-BZ-T8-0004 (\$93,350) and 2008-BZ-T8-0005 (\$193,030), and directs the Des Moines Police Department to complete the scope of work identified in the Buffer Zone Protection Program and Vulnerability Reduction Purchasing Plan as approved by the U.S. Department of Homeland Security, Office of Grants and Training, and Iowa Homeland Security and Emergency Management Division.
