**APPROVAL OF THE IOWA COMMUNITY SERVICES BLOCK GRANT (CSBG) FY 2009
CSBG AMERICAN RECOVERY AND REINVESTMENT ACT (ARRA) CONTRACT**

WHEREAS, in order to continue funding local community action service programs, the City's Community Development Department, as a Community Action Agency for the Community Services Block Grant (CSBG) Program, prepared the City of Des Moines' FY2009 CSBG American Recovery and Reinvestment Act (ARRA) Agency Plan in the amount of \$875,471 in CSBG funds, which Plan was approved by City Council on May 18, 2009 by Roll Call No. 09-856, and was thereafter submitted to the Iowa Department of Human Rights, Division of Community Action Agencies; and

WHEREAS, the FY2009 CSBG-ARRA Agency Plan provides a detailed description of the community services needs of the City's low-income residents and provides a comprehensive non-duplicative approach for addressing those needs; and

WHEREAS, the Iowa Department of Human Rights, Division of Community Action Agencies has approved the City's FY2009 CSBG-ARRA Agency Plan and has forwarded a CSBG American Recovery and Reinvestment Act Contract (No. CSBG-R9-07) for approval by the City for funding of the Agency Plan in the amount of \$875,471.00, which Contract is on file in the Clerk's Office and by this reference made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above-referenced CSBG American Recovery and Reinvestment Act Contract (No. CSBG-R9-07) between the City and the Iowa Department of Human Rights, Division of Community Action Agencies, is hereby approved, the Mayor is authorized and directed to execute said Contract, and the City Clerk is directed to attest to his signature.

BE IT FURTHER RESOLVED that the City Manager is hereby designated and authorized to negotiate on behalf of the City any changes to administrative terms and conditions of the Contract, except for changes related to the project budget amounts specified in the Contract, and the City Manager is further authorized and directed to sign Contract amendments related to such negotiated changes.

BE IT FURTHER RESOLVED that the Community Development Director or his designee is hereby authorized and directed to implement and administer the Contract and to certify, sign and submit all program and fiscal forms, funding requests and reports related to this Contract.
