RESOLUTION AUTHORIZING CONSENT TO CONSERVATION EASEMENT AGREEMENT FOR PRESERVATION OF THE OLD CENTRAL LIBRARY BUILDING

WHEREAS, by Roll Call No. 01-3105 of October 8, 2001, the City Council directed City staff in conjunction with the Capitol City Vision Iowa Project to negotiate terms for the development of The World Food Prize Center in the old central library building; and

WHEREAS, by Roll Call No. 03-1531 of June 23, 2003, the City Council approved a joint application with The World Food Prize Foundation for a National Park Service \$300,000 Save America's Treasures Grant for architectural planning and design for the World Food Prize Center in the old central library building; and

WHEREAS, City staff has proposed urban renewal competitive disposition procedures and has negotiated a draft urban renewal lease agreement for the proposed restoration and renovation of the old central library building for a World Food Prize Hall of Laureates or other community betterment project; and

WHEREAS, The World Food Prize Foundation is in the process of finalizing its urban renewal development proposal for the lease of the old central library building; and

WHEREAS, as a condition to finalizing its Save America's Treasures Grant, The World Food Prize Foundation has signed a Conservation Easement Agreement for preservation of the old central library building with the Historical Division of the Iowa Department of Cultural Affairs and the City is required to consent to such document.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City of Des Moines does hereby consent to the Conservation Easement Agreement between The World Food Prize Foundation and the Historical Division of the Iowa Department of Cultural Affairs, on file in the Office of the City Clerk, and the Mayor is hereby authorized and directed to execute the consent to such Agreement on behalf of the City and the City Clerk is directed to attest to his signature.


