APPROVING A MEMORANDUM OF UNDERSTANDING BETWEEN DES MOINES STORMWATER MANAGEMENT UTILITYAND THE DES MOINES INTERNATIONAL AIRPORT FOR CONSTRUCTION AND JOINT OPERATION OF THE MCKINLEY STORM WATER DETENTION BASIN

WHEREAS, the City of Des Moines owns and operates an airport known as the Des Moines International Airport (the "Airport"), located in Des Moines, Polk County, Iowa; and

WHEREAS, Chapter 22 of the Des Moines City Code delegates certain rights and responsibilities pertaining to the operation of the Airport to the Des Moines International Airport Board (the "Board") including the power to review and either approve or disapprove all plans associated with development or redevelopment of the airport; and

WHEREAS, the Des Moines City Council acts as the governing body of the Des Moines Stormwater Management Utility established under Des Moines City Code chapter 118, Division VI; and

WHEREAS the City owns a parcel of land that abuts McKinley Avenue and is held by the City for airport purposes; and

WHEREAS, the Stormwater Management Utility desires to use the property for the public purpose of constructing and maintaining a storm water detention basin to provide flood protection south and east of McKinley Avenue; and

WHEREAS, the Stormwater Management Utility's proposed use of the property is acceptable to the Federal Aviation Administration as an appropriate use; and

WHEREAS, staff from the Airport and the Stormwater Management Utility have agreed upon the terms of a Memorandum of Understanding describing the detention basin project and permitting the Stormwater Management Utility to continue to use the property for the detention basin for a period of 50 years unless it is needed sooner by the Airport for airport purposes; and

WHEREAS, the Airport Board has approved and the Board Chair has executed the Memorandum of Understanding; and

WHEREAS, it is in the best interests of the City to approve the Memorandum of Understanding.
