**RESOLUTION APPROVING AGREEMENTS AND RELATED DOCUMENTS  
FOR THE COMMUNITY DEVELOPMENT NEIGHBORHOOD CONSERVATION  
SERVICES NEIGHBORHOOD STABILIZATION PROGRAM.**

WHEREAS, Section 2301 of the Housing and Economic Recovery Act of 2008 created the Neighborhood Stabilization Program (NSP); and,

WHEREAS, Congress allocated \$3.92 billion of Community Development Block Grant funds to the NSP for state and local governments to provide emergency assistance redeveloping abandoned and foreclosed homes; and,

WHEREAS, the State of Iowa received \$21.6 million to allocate to cities within the State; and,

WHEREAS, the State of Iowa submitted a plan to HUD which allocated \$3.9 million to the City of Des Moines; and,

WHEREAS, the City of Des Moines submitted a plan to the State of Iowa to describe how it will allocate these funds; and,

WHEREAS, the State of Iowa approved the City's plan to allocate the funds; and,

WHEREAS, the City has worked with several housing agencies and for-profit contractors to develop a plan to implement the program; and,

WHEREAS, the City plans to work with local housing agencies and private contractors on a property-specific basis to finalize redevelopment plans; and,

WHEREAS, the City will enter into property-specific contracts and related documents with the local housing agency or private contractor to implement the program and the City Council finds the form of the attached documents to be acceptable.
