

RESOLUTION APPROVING ECONOMIC DEVELOPMENT GRANT TO HUBBELL HOMES FOR REDEVELOPMENT OF 2016 AND 2024 FOREST AVENUE WITH 9 LOW INCOME HOUSING UNITS

WHEREAS, subject to receipt of the economic development assistance identified below, Hubbell Homes, L.C., represented by Rick Tollakson, President, proposes to construct a nineplex housing structure at 2016 and 2024 Forest Avenue, to be owned and managed by Anawim, represented by Sister Stella Neill, Executive Director; and,

WHEREAS, Anawim will use the structure to provide affordable housing to low-income families; and,

WHEREAS, parcels at 2016 and 2024 Forest Avenue are located within the Forest Avenue Urban Renewal Area and the redevelopment of the parcels for low-income housing as proposed by Hubbell Homes is consistent with the following goals and objectives of the Forest Avenue Urban Renewal Plan:

- Provide an attractive and appealing physical environment for residents to improve the livability of the Urban Renewal Area.
- Continue to support the construction of quality residential infill projects on cleared or vacant parcels.
- Expand housing opportunities for residents.
- Remove blighting physical conditions that cause or contribute to a shortage of decent, safe and sanitary housing and constitute a menace to the public health, safety, morals and welfare.
- Ensure new development is of high quality, sustainable and provides adequate parking and pedestrian connections and access.

WHEREAS, the City Manager has negotiated an agreement with Hubbell Homes and Amawim whereby they agree to construct and maintain the nine-plex as described above in exchange for an economic development grant to be paid by the City to Hubbell Homes upon substantial completion of the nine-plex, in an amount equal to the total amount of the City of Des Moines' permit fees charged by the project, as more specifically described in the accompanying Council Communication; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:
