AUTHORIZING AMENDMENT TO THE TERMS OF THE HOME LOAN WITH OAKRIDGE NEIGHBORHOOD ASSOCIATES, L.P. FOR RENOVATION OF LOW INCOME RENTAL HOUSING

WHEREAS, a Limited Partnership known as Oakridge Neighborhood Associates, L.P has been formed to purchase and renovate 150 housing units at the Homes of Oakridge, 1236 Oakridge Drive, Des Moines; and

WHEREAS, on October 12, 2007 by Roll Call No. 09-1853 the City Council approved the execution of Home Documents for \$1,050,000 for renovation of 150 units of low income rental housing for Oakridge Neighborhood Associates, L.P.

WHEREAS, the original terms of the loan were such that the City would receive a 1% interest rate payment annually for 16 years plus full payment of the \$1,050,000 in year 17; and

WHEREAS, the developer has requested that the term of the loan be extended to 30 years in order to have the same term as a Flexible Subsidy Loan provided by the Multi-Family Division of the U.S. Department of Housing and Urban Development;

WHEREAS, the City will receive an interest payment annually of \$10,500 in years 1 through 29 when the loan will be due in full;

WHEREAS, the extension of the term of the loan is still in compliance with the City's policy for Low Income Housing Tax Credit projects adopted on March 20, 2006 by Roll Call 06-569; and

WHEREAS, staff has prepared the amended HOME contract document for this project which are on file in the Office of the City Clerk;
