APPROVING ASSIGNMENT AND ASSUMPTION OF
CLAIMS AGREEMENT BETWEEN THE CITY OF DES MOINES AND
ELDER CORPORATION FOR DAMAGE TO COWNIE SOCCER FIELDS

WHEREAS, on June 8, 2009 by Roll Call No. 09-1042, the City of Des Moines, Iowa entered into a contract with Elder Corporation as general contractor for a public improvement project, Cownie Soccer Fields Improvements - Phase 3, at the James W. Cownie Soccer Park ("Soccer Park"), located at SE 22nd Street and Hartford Avenue in Des Moines and owned by the City; and

WHEREAS, on or around October 7, 2009, it was discovered that certain fields within the Soccer Park had been trespassed upon by horses kept at 3111 Hartford Avenue, Des Moines (Property Owner: Park Avenue Farms L.C.), and that significant damage had been caused by such trespass to the Soccer Park and fields therein; and

WHEREAS, the Parks Department needed the damage fixed quickly so that the fields would be available for soccer games next year, and if the damage was not repaired and new sod laid before winter, the fields would have been unavailable for play next year; and

WHEREAS, on October 26, 2009, by Resolution No. 09-1905 the City Council approved Change Order No. 2 between the City of Des Moines and Elder Corporation for additional work on the Cownie Soccer Fields Improvements - Phase 3 in an amount not to exceed \$90,420 so that the work could proceed quickly so that the fields will be available for soccer games next year; and

WHEREAS, in consideration of Change Order No. 2, the Legal Department has prepared an Assignment and Assumption of Claims Agreement between the City and Elder by which Elder assigns all of its right and interest in and to any and all claims, demands, suits, damages, losses or causes of action that may be asserted or claimed against or recovered from any and all parties arising out of or relating to the trespass on the Soccer Park by the horses to the City; and
