Approval of Assignment of Commercial Operator Lease and Agreement from Mid-America Transportation Inc. dba Mid-America Jet Center to Elliott Aviation of Des Moines, Inc.

WHEREAS, on June 18, 2007, by Roll Call 07-1231, the Des Moines City Council approved a Commercial Operator Lease and Agreement ("Agreement") with Mid-America Transportation Inc. dba Mid-America Jet Center ("Mid-America"); and

WHEREAS, in recent months Mid-America initiated a sale of its commercial operations at the Airport, including assumption of this Agreement; and

WHEREAS, on December 31, 2009, Mid-America was able to negotiate terms of a sale to Elliott Aviation of Des Moines, Inc. ("Elliott"), a fixed based operator tenant located immediately west of MidAmerica; and

WHEREAS, part of the condition of the sale is an assignment of the Agreement, which is subject to City approval; and

WHEREAS, Chapter 22 of Des Moines City Code assigns certain rights and responsibilities pertaining to the Airport to the Des Moines International Airport Board, but reserves for the City Council the authority to enter into agreements of greater than three years duration affecting real estate; and

WHEREAS, the current Agreement is set to expire on June 30, 2017, and, therefore, being for a term of greater than three years, requires approval by the Des Moines City Council; and

WHEREAS, on January 5, 2010, by resolution A10-015, the Airport Board recommended approval of the assignment; and

WHEREAS, notice of the hearing on the proposed assignment has been duly published; and

WHEREAS, the City Council believes it is in the best interest of the City to approve the assignment;
