AUTHORIZATION FOR THE CITY ENGINEER TO ADMINISTER
CDBG DISASTER RECOVERY INFRASTRUCTURE GRANTS
WITH THE IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the City Engineer, or his designee, be and is hereby authorized and directed to administer the following Iowa Department of Economic Development grants on behalf of the City of Des Moines and to execute all documents associated with said grants:

- Contract Number 08-DRI-005 in the amount of \$2,500,000 for Five Storm Water Pump Stations in the Birdland and Central Place Areas,
- Contract Number 08-DRI-006 in the amount of \$2,000,000 for Livingston Avenue Storm Sewer System Lining,
- Contract Number 08-DRI-007 in the amount of \$1,200,000 for Lining of the Sanitary Sewers in the Eastern Portion of the Highland Hill Sanitary Sewer Subsystem,
- Contract Number 08-DRI-232 in the amount not to exceed \$4,000,000 for the Court Avenue - Water Street Sewer Separation Project.
- Contract Number 08-DRI-233 in the amount not to exceed \$5,000,000 for the Lower Union Sewer Separation Project.
- Contract Number 08-DRI-234 in the amount not to exceed \$1,200,000 for the 33rd Street Sewer Separation Project.
- Contract Number 08-DRI-235 in the amount not to exceed \$5,000,000 for the Jackson Basin Pump Station Project.
- Contract Number 08-DRHB-221 in the amount not to exceed \$815,460 for property acquisition and demolition of certain properties in the Four Mile Area.
