APPROVING THE PROCUREMENT OF PUMPS AND RELATED EQUIPMENT FOR THE BIRDLAND SANITARY LIFT STATION FROM ELECTRIC PUMP & TOOL SERVICES INC. AND AUTHORIZING FINANCE DEPARTMENT TO ISSUE PAYMENT FOR SAME

WHEREAS, the Public Works Department Sewer Enterprise Division has procured pumps and related equipment for the Birdland Sanitary Lift Station in the amount of \$47,633.15; and

WHEREAS, on December 18, 2000, by Roll Call # 00-4569, the Des Moines City Council approved and authorized the execution of a contract with Electric Pump & Tool Services, Inc., 4280 NE 14th Street, Des Moines, IA 50313, Richard Miller, President, for the provision of new pumps for new pump stations, for the provision of replacement pumps for existing pump stations, for the provision of pump repair parts and management of the City's pump repair parts inventory, and for the provision of pump repair services; and

WHEREAS, on December 5, 2005, by Roll Call # 05-2900, the Des Moines City Council approved and authorized the execution of addendum and amendment to said contract with Electric Pump & Tool Services, Inc. wherein the Des Moines Metropolitan Wastewater Reclamation Authority (WRA) was added as a party to the contract, the contract was renewed for a 3-year term, and the Master Price Listing was replaced; and

WHEREAS, on December 8, 2008, by Roll Call # 08-2138, the Des Moines City Council approved and authorized the execution of an addendum to said contract with Electric Pump & Tool Services Inc., wherein the contract was renewed for another 3-year term, and the Master Price Listing was replaced; and

WHEREAS, the pump at the Birdland Sanitary Lift Station that performs a majority of the pumping at the station failed and requires timely replacement; and

WHEREAS, the Public Works Department Sewer Enterprise Division has been advised the replacement pump has been installed at the price established in the approved purchase contract with Electric Pump & Tool Services Inc., and the Public Works Department Sewer Enterprise Division is requesting City Council approve this procurement from Electric Pump & Tool Services Inc. for this installed pump; and

WHEREAS, funding is available from PWK990000/SAE126, Capital Projects/Lower Union Park Sewer Separation.
