RESOLUTION PARTIALLY RELEASING THE PUD RESTORATION BOND FOR THE WOODS OF COPPER CREEK DEVELOPMENT

WHEREAS, on May 19, 2008, by Roll Call No. 08-862, the City Council approved the PUD Restoration Bond for The Woods of Copper Creek development, located in the vicinity of 4680 NE 23rd Avenue (also known as Easton Boulevard), and accepted PUD Restoration Bond #IAC87624 from Eclo-Tech Construction, L.L.C., as principal and Merchant's Bonding Company as surety, in the amount of \$248,782 as security for the estimated cost of completing the required grading and site restoration for such development project; and,

WHEREAS, the City Engineer and Community Development Director have certified that the required grading and site restoration have been partially completed and recommend that the security be partially released and reduced to \$20,000; NOW THEREFORE,
