WHEREAS, on November 24, 2008 by Roll Call No. 08-2049, in response to the above referenced COC application, the City Council approved 2007 Supportive Housing Program (SHP) Renewal Grant Agreements by and between HUD and the City of Des Moines, in the amount of \$110,250 for the Iowa Institute for Community Alliances for the Iowa's Continuum Outcome and Universal Need Toolkit projects; and

WHEREAS, HUD has now forwarded Continuum of Care Grantee Closeout Certifications for the Iowa's Continuum Outcome and Universal Need Toolkit Projects, which Certifications are on file with the City Clerk as Exhibits A, and by this reference made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Mayor is hereby authorized and directed to sign the above-referenced Closeout Certifications and the City Clerk to attest to his signature.
