WHEREAS, the City of Des Moines Community Development Department staff reviewed and included in an Environmental Review Record (ERR) the activities to be undertaken in the 2010 CFP pursuant to 24 CFR Part 58, and found them to be considered "Exempt" under 24 CFR Part 58.34(a)(3), (8) and (10); and

WHEREAS, the City of Des Moines Community Development Department staff recommends that no further environmental review be conducted and a request for the immediate release of funds for activities included in the 2010 CFP be submitted to HUD.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Environmental Review Record ("Finding of Exemption") for the 2010 Capital Fund Program, on file with the City Clerk as Exhibit "A" and by this reference made a part hereof, and the findings and recommendations of the City Community Development Department staff are hereby approved.
