> RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION OF THE ISSUANCE OF NOT TO EXCEED \$520,000 GENERAL OBLIGATION BONDS (FOR GENERAL CORPORATE PURPOSES) AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, the City of Des Moines, Iowa is in need of funds to carry out general corporate purpose projects as hereinafter described; and, it is deemed necessary that it should issue General Obligation Bonds to the amount of not to exceed \$520,000 as authorized by Section 384.26 of the City Code of Iowa, for the purpose of providing funds to pay costs thereof; and

WHEREAS, said City has a population in excess of 75,000 and the amount of said Bond issue is not more than \$1,000,000; and

Section 1. That this Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 26th day of April, 2010, for the purpose of taking action on the matter of the issuance of not to exceed \$520,000 General Obligation Bonds, the proceeds of which Bonds will be used to provide funds to pay costs of the acquisition and installation of system and equipment upgrades, extensions and enhancements to the City's enterprise communications and data management systems, including voice systems, data and communications infrastructure, enterprise software applications and data management systems, and shall bear interest at a rate not exceeding the maximum specified in the attached notice.
