APPROVING AND AUTHORIZING THE EXECUTION OF  
IOWA DEPARTMENT OF TRANSPORTATION (IDOT)  
PRECONSTRUCTION AGREEMENT FOR THE  
DEANS LAKE OUTFALL ALONG THE UNION PACIFIC RAILROAD  
TO DEANS LAKE PHASE 2 PROJECT

WHEREAS, the City Council, by Roll Call 00-3634, on August 31, 2000, approved a Predesign Agreement with the Iowa Department of Transportation (IDOT) for Interstate 235, from the west city limits to the north city limits; and

WHEREAS, the City Council, on December 8, 2003, by Roll Call 03-2692, approved a Preconstruction Agreement with IDOT for Deans Lake Outfall along the Union Pacific Railroad to Deans Lake Phase 1 Project; and

WHEREAS, the IDOT will take bids and perform contract administration for the work; and

WHEREAS, a Preconstruction Agreement has been negotiated with the IDOT to identify the responsibilities of the IDOT and City regarding the administration, funding, and implementation of the project construction.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Preconstruction Agreement between the City of Des Moines and the Iowa Department of Transportation for the Deans Lake Outfall along the Union Pacific Railroad to Deans Lake Phase 2 Project, be and is hereby approved subject to approval by the Iowa Department of Transportation, and the Mayor is authorized and directed to sign such Agreement and the City Clerk to attest to the Mayor's signature and return two original copies to the Engineering Department for transmittal to the Iowa Department of Transportation.
