ACCEPTING STATE OF IOWA OFFICE OF ENERGY INDEPENDENCE (OEI) ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT (EECBG) FUNDING IN THE AMOUNT OF \$83,225, APPROVING GRANT CONTRACT FOR SAME AND AUTHORIZING MAYOR TO EXECUTE SUCH CONTRACT, AND AUTHORIZING CITY MANAGER TO NEGOTIATE AND EXECUTE ASSIGNMENT AND ASSUMPTION AGREEMENT OF SAID GRANT TO WRA

WHEREAS, the City of Des Moines places a high priority on efficient energy use; and

WHEREAS, the State of Iowa OEI provides EECBG funds to local governmental entities to fund activities and programs via a competitive grant process, to assist local governments in creating and implementing strategies to: 1) Reduce fossil emissions in a manner that is environmentally sustainable, and to the maximum extent practicable, maximize benefits for local and regional communities, 2) Reduce total energy use of the eligible entities, 3) Improve energy efficiency in the building, transportation and other appropriate sectors, and 4) Create and retain jobs; and

WHEREAS, the staff of the Des Moines Metropolitan Wastewater Reclamation Authority (WRA) applied for an EECBG with the OEI; and

WHEREAS, OEI has indicated that they will only award grants to a municipality and offered the award to the City of Des Moines in the amount of \$83,225.00 for the installation of a Continuous Commissioning System; and

WHEREAS, the OEI requires the City to execute an Energy Efficiency and Conservation Block Grant Sub-Recipient Contract (Grant Contract), a copy of which is on file in the City Clerk's Office, in order to receive such grant payments and

WHEREAS, such Grant Contract requires the City to provide a dollar to dollar match and the WRA has such funds available; and

WHEREAS, section 13.3 of the Grant Contract requires the written consent of OEI to the assignment of the Grant Contract, and written approval of the OEI to assign said Grant Contract to the WRA has been received by the City; and

WHEREAS, on April 20, 2010, by Resolution No. 10-60, the WRA Board approved a resolution authorizing the WRA Director to enter into an agreement with the City of Des Moines in which the WRA agrees to comply with the terms of said Grant Contract, including being responsible to the City for all violations of the grant agreement by the WRA and authorizing the WRA Director to administer the grant funds in accordance with the grant terms.
