**APPROVING AND AUTHORIZING THE EXECUTION OF IOWA JOBS PROGRAM  
GRANT AWARD AGREEMENT WITH THE IOWA JOBS BOARD AND THE IOWA  
FINANCE AUTHORITY FOR \$2,205,000 FOR THE BIRDLAND LEVEE  
REPLACEMENT**

WHEREAS, on July 27, 2009 by Roll Call No. 09-1395, the City Council authorized submittal of the Birdland Levee Replacement project application to the Iowa Finance Authority (IFA) under the Iowa's Infrastructure Investment Initiative (I-Jobs) Program; and

WHEREAS, on August 31, 2009, IFA notified the City of Des Moines that they had awarded the CITY I-Jobs funding in the amount not to exceed \$2,205,000 for the Birdland Levee Replacement project; and

WHEREAS, on October 12, 2009 by Roll Call 09-1833, the City Council Approved the Project Partnership Agreement with the Department of the Army for construction of the Birdland Park levee wetland mitigation and downtown closure improvements; and

WHEREAS, City staff has worked with IFA to negotiate a contract with the City that references the Project Partnership Agreement between the City and the Department of the Army; and

WHEREAS, the Grant Award Agreement was approved by the Iowa Jobs Board on May 5, 2010 and by Iowa Finance Authority on May 6, 2010; and

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Iowa Jobs Program Grant Award Agreement for the Birdland Levee Replacement project, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized and directed to execute, said grant contract and other related documents on behalf of the City of Des Moines, Iowa.
