## SELECTION AND APPROVAL OF AGREEMENT WITH SAFE WORKS OF IOWA, P.L.L.C. FOR OCCUPATIONAL HEALTH SERVICES

WHEREAS, since March 2003, Des Moines University ("DMU") has provided occupational health services for City of Des Moines employees; and

WHEREAS, DMU advised the City that it would discontinue such services as of June 30, 2010; and

WHEREAS, the City issued a Request for Proposal ("RFP") to select a qualified vendor to provide occupational health services for a three year period beginning July 1, 2010; and

WHEREAS, three companies submitted proposals to provide occupational health services; and

WHEREAS, a committee representing the police, fire, public works, parks, engineering and human resources departments reviewed the proposals; and

WHEREAS, Safe Works of Iowa, P.L.L.C. (Medical Director Sunil Bansal, M.D., M.P.H.), 13375 University Ave., Suite 100, Clive, Iowa 50325 submitted the lowest bid for occupational health services as outlined in the attached council communication; and

WHEREAS, it is recommended that the City select Safe Works of Iowa to provide occupational health services for the period July 1, 2010-June 30, 2011 with two one year options to renew so long as the cost in the second year does not exceed a 4% rate increase and another 4% in the third year all subject to the vendor opening its Des Moines site.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa;

- 1. That Safe Works of Iowa is selected as the provider for occupational health services and the legal department is directed and authorized to negotiate an agreement with Safe Works of Iowa for such services for a term of up to three years; and
- 2. The Mayor is authorized to execute such agreement as approved by the legal department for and on behalf of the City of Des Moines, Iowa and as attested to by the City Clerk; and
- 3. The City Manager is authorized to execute the two one year renewals.
