WHEREAS, on November 24, 2008, by Roll Call Number 08- 2075 , the City Council adopted the 2009 Consolidated Plan which includes the Economic Development Financing Assistance Program, and

WHEREAS, on November 9, 2009, by Roll Call Number 09- 2055, the City Council adopted the 2010 Consolidated Plan which includes the Economic Development Financing Assistance Program; and

WHEREAS, the Economic Development Financing Assistance Program includes the Loan Injection, Revolving Loan Fund and MicroLoan Programs, whereby The Corporation for Economic Development in Des Moines will act as an agent of the City in such programs, pursuant to the 28E Agreement, on file with the City Clerk

WHEREAS, the City Office of Economic Development will provide staffing for loan packaging, loan servicing, marketing and management activities pursuant to the Professional Services Agreement on file with the City Clerk.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that pursuant to the above-referenced 28E Agreement between the City of Des Moines and The Corporation for Economic Development in Des Moines, The Corporation for Economic Development in Des Moines will act as an agent for the City in administering the Loan Injection, Revolving Loan Fund and MicroLoan programs and the Mayor is hereby authorized and directed to sign the 28E Agreement and the City Clerk is authorized and directed to attest to his signature.

BE IT FURTHER RESOLVED that the Professional Services Agreement is hereby approved, the Mayor is hereby authorized and directed to sign the agreement and the City Clerk is authorized and directed to attest to his signature.




