WHEREAS, said Page 3 of the Proposal Attachment includes part of the Contract Compliance Program Requirements (which did not apply to this project) and General Additional Requirements; however, the bidder is not required to provide any information on any of these missing pages. Ms. Terri Mevissen at Upper Midwest Athletic Construction stated that they will comply with the requirements, and inadvertently left the page out when they assembled their proposal. Even though Upper Midwest Athletic Construction did not return all the proposal sheets, Upper Midwest Athletic Construction did complete and returned all the proposal sheets requiring information to be supplied by the bidder. The Engineering Department will include said missing pages in the contract documents to be signed by Upper Midwest Athletic Construction. After further review, the Engineering and Legal Departments have determined that this was a minority irregularity that could be waived by the City Council.
