## APPROVING PROFESSIONAL SERVICES AGREEMENT WITH AECOM, INC. FOR DESIGN AND CONSTRUCTION PHASE SERVICES FOR THE MULBERRY STREET PAVING – $13^{th}$ STREET TO $15^{th}$ STREET

WHEREAS, on May 24, 2010, by Roll Call No. 10-856, the City Council authorized the City Manager to proceed with the design of Mulberry Street Paving between 13<sup>th</sup> and 15<sup>th</sup> Streets; and

WHEREAS, the Engineering Department solicited proposals from two local consulting firms having expertise and experience with similar projects in the area; and

WHEREAS, a selection committee from the Engineering Department scored the proposals and determined that AECOM, Inc. was most qualified.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Professional Services Agreement between the City of Des Moines and AECOM, Inc., Steven J. Eaton, Principal in Charge, 500 SW 7<sup>th</sup> Street, Suite 301, Des Moines, IA, 50309, for professional services for the Mulberry Street Paving – 13<sup>th</sup> Street to  $15^{th}$  Street, for an hourly agreement not to exceed \$195,000, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreement for and on behalf of the City of Des Moines, Iowa.
