PUBLIC HEARING REGARDING APPROVING ON-AIRPORT AUTOMOBILE RENTAL CONCESSION AND LEASE AGREEMENT AT THE DES MOINES INTERNATIONAL AIRPORT WITH DTG OPERATIONS, INC. (DBA DOLLAR RENT A CAR AND THRIFTY CAR RENTAL)

WHEREAS, the City owns and operates the Des Moines International Airport (Airport); and

WHEREAS, the City and various rental car operators, have in the past entered into On-Airport Automobile Rental Concession and Lease Agreements covering all aspects of automobile rentals at the Airport; and

WHEREAS, the current agreements are scheduled to terminate on July 31, 2010, and

WHEREAS, staff has recently completed a competitive bidding process; and

WHEREAS, on June 1, 2010, by Resolution No. A10-114, the Airport Board approved the successful bidders and recommended that the City Council approve agreements with each; and

WHEREAS, staff and representatives of the successful bidders have agreed to terms and conditions of a proposed five-year concession agreement; and

WHEREAS, DTG Operations, Inc. (dba Dollar Rent A Car and Thrifty Car Rental) was a successful bidder and desires to provide car rental services at the Airport and lease facilities and premises at the Airport; and

WHEREAS, the term of the proposed agreement begins on August 1, 2010, and is scheduled to terminate on July 31, 2015, so being greater than three years, requires approval of the City Council; and

WHEREAS, on May 24, 2010, by Roll Call No. 10-860, City Council set a date of hearing on the proposed agreements for June 14, 2010, and directed the City Clerk to publish notice of the hearing; and

WHEREAS, on June 14, 2010, by Roll Call No. 10-976, City Council continued the public hearing on the proposed agreement with DTAG until June 28, 2010, at 5:00 PM.

WHEREAS, pursuant to Sections 364.7 and 362.3 of the Code of Iowa, notice of the hearing has been duly published as provided by law; and
