PUBLIC HEARING ON LOWER UNION PARK SEWER SEPARATION REGARDING:

- 1. APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE; AND
- 2. THE STATUS OF THE FUNDED ACTIVITIES UNDER IDED CONTRACT 08-DRI-033; ALSO RESOLUTION TO RECEIVE AND FILE BIDS; DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS VAN HAUEN & ASSOCIATES, INC., BRIAN TANCOS, PRESIDENT, \$4,337,374.40

WHEREAS, on June 14, 2010, under Roll Call No. 10-880, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

This improvement includes approximately 9,300 linear feet of 12-inch through 60-inch storm sewer pipe, 880 linear feet of 12-inch through 20-inch sanitary sewer pipe, 24,000 square yards of PCC pavement, 1,500 tons of 2-inch HMA overlay, 1,800 square yards of PCC driveway, 3,450 square yards of PCC sidewalk, storm and sanitary manholes, intakes, sanitary sewer service line, erosion control, tree removal and protection, sewer abandonment and other related items; all in accordance with the contract documents, including Plan File Nos. 517-050/121. This project is located along Thompson Avenue from East Ninth Street to York Street, on East 12th Street and on East 13th Street from Thompson Avenue to Mattern Avenue, on East Washington Avenue from Pennsylvania Avenue to East Ninth Street, on East Ninth Street to East 13th Street, on Garfield Avenue from East Ninth Street to East 12th Street, on East 13th Street from East Washington Avenue from East Ninth Street to East 12th Street, on East 13th Street from East Washington Avenue from East Ninth Street to East 12th Street, on East 13th Street from East Washington Avenue to East Sheridan Avenue; all in the City of Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, on June 16, 2010, notice was also published of a hearing pursuant to the requirements of Section 508 of the Housing and Community Development Act of 1987, as amended. The purpose of the hearing is to discuss the status of funding for the proposed Lower Union Sewer Separation Project, Iowa Department of Economic Development Contract Number 08-DRI-033. This project includes approximately 9,300 linear feet of 12-inch through 60-inch storm sewer pipe, 880 linear feet of 12-inch through 20-inch sanitary sewer pipe, 24,000 square yards of PCC pavement, 1,500 tons of 2-inch HMA overlay, 1,800 square yards of PCC driveway, 3,450 square yards of PCC sidewalk, storm and sanitary manholes, intakes, sanitary sewer service line, erosion control, tree removal and protection, sewer abandonment and other related items; all in accordance with the contract documents, including Plan File Nos. 517-050/121. This project is located along Thompson Avenue from East Ninth Street to York Street, on East 12th Street and on East 13th Street from Thompson Avenue to Mattern Avenue, on East Washington Avenue from Pennsylvania Avenue to East Ninth Street, on East Ninth Street from East Washington Avenue to Garfield Avenue, on Cleveland Avenue from East Ninth Street to East 13th Street, on Garfield Avenue from East Ninth Street to East 12th Street, on East 13th Street from East Washington Avenue south 1/2 block, on East 15th Street from Garfield Avenue to East University Avenue and on East 13th Street from Morton Avenue to East Sheridan Avenue; all in the City of Des Moines, Iowa. The project is being funded in part through a Community Development Block Grant provided by the Iowa Department of Economic Development and Des Moines Storm Water Utility Funds, as detailed in the Council Communication.
